

## Churches designated under the Sharing of Church Buildings Act 1969

### Churches to which The Act Applies, Authorities, Parties & Consents

There follows the **DATE** from which the Act has applied; the **NAME** of the church(es) concerned; the **APPROPRIATE AUTHORITIES** required by the Act to be designated as those responsible (a) for determining who the parties to a particular sharing agreement shall be, i.e. who actually signs it; and whose consents shall be required for it, i.e. whose approval must formally be obtained according to the church's polity before the sharing agreement can be signed; and (b) for keeping a register of sharing agreements; the **PARTIES** so determined; and the **CONSENTS** required before a sharing agreement can be entered into.
